#### Company

### Court of Protection: Health and Welfare

Helen accepts instructions in a wide range of health and welfare cases, including section 21A and section 16 applications, and disputes relating to capacity and ordinary residence. Helen sits as a fee paid judge in the Mental Health Tribunal, and has a keen interest in cases involving the intersection of the Mental Health Act 1983 and the Mental Capacity Act 2005.

Representing a servicewoman in her claim against the Ministry of Defence for disability and sex discrimination.

Successfully arguing that a company was responsible for the actions of its shareholder who had made comments which were allegedly discriminatory on grounds of religious belief. The comments were disclosed by an anonymous third party, in circumstances which were alleged by the Respondent to be illegal. Following lengthy submissions, the comments were found to be admissible.

#### **Real Estate Litigation**
