Sarah specialises in all areas of Town and Country Planning, and took Silk in 2022. She is consistently rated highly by all the leading directories and publications (Legal 500, Chambers and Partners, The Planner's Women of Influence List and Planning Magazine).

Sarah has extensive experience across the full range of planning matters including large scale housing schemes, retail, renewable energy, waste, enforcement and compulsory purchase. She regularly appears in planning inquiries and hearings, enforcement inquiries, local plan examinations, statutory challenges and judicial review proceedings.

She has a particular specialism and extensive experience in large scale housing schemes and has represented many of the national developers and land promoters in this capacity. Recent examples in 2021/2022 include successfully representing Bloor Homes in an inquiry to secure permission for 662 homes at Rochford; successfully representing the developer in an inquiry relating to a greenfield site in Maldon to secure permission for 232 dwellings together with a full award of costs; and successfully representing the only Appellant to achieve planning permission in a combined inquiry relating to 6 greenfield sites promoted by different developers at Goosnargh Preston and Longridge (instructed by Emery Planning).

Sarah also has significant experience in promoting schemes relating to specialist accommodation for the elderly, including, by way of example, on behalf of developers such as McCarthy and Stone and Churchill Retirement Living.

Sarah has extensive experience in other complex planning matters. By way of example, she has acted in 2 significant MSA inquiries in the last year, one for an Appellant and the other for a LPA. She also represented one of the LPAs in the called – in inquiry at Parkside – a proposal for a link road between the A49 and M6 to open up a green belt site for major logistics development and SRFI.

Sarah frequently advises on Local Plan preparation and appears at Local Plan Examinations. Within the last year (2021/2022), she has represented a major developer promoting a proposed employment allocation through the Local Plan process and is providing ongoing advice to three LPAs on their emerging Local Plans.

Sarah also specialises in highways and rights of way matters, and prior to taking Silk was the Assistant Editor of the leading practitioner's text on the subject (the Encyclopedia of Highway Law and Practice).

Prior to taking Silk, Sarah was appointed as Junior Counsel to the Crown on its leading "A Panel", regularly advising and appearing on behalf of the Secretary of State in the most complex of planning matters and statutory challenges. A recent example is *Sefton v SSCHLG and Doherty* [2021] EWHC 1082, where the Court accepted Sarah's submissions relating to the correct interpretation of Green Belt policy.

Sarah was instrumental in establishing Women in Planning North – West and has sat on its committee since its inception. She also sits on the committee for the Planning and Environmental Bar Association (PEBA). She has provided training to Planning Inspectors in that capacity on numerous occasions and was also Chair of the PEBA – PINS Working Group, which sought to establish protocols for virtual hearings and inquiries during the pandemic.
