Francesca regularly acts in complex welfare proceedings and has a particular interest and experience in cases involving: cross border placements and disputes (with particular interest in cross border placements from Scotland); children and deprivation of liberty; the international protection of adults (for example, Francesca has recently been instructed to advise on cases involving Japan, Kenya and the United States of America); cases involving both welfare and financial disputes; and safeguarding vulnerable adults within the Inherent Jurisdiction of the High Court.

Francesca's practice is unique in that Francesca specialises in Health & Welfare and Property & Affairs within the Court of Protection. Francesca's property and affairs practice regularly involves advising on issues relating to: the scope of the role of a financial deputy, lasting powers of attorney; statutory wills and financial abuse.

### **Court of Protection & Mental Health**

Francesca has experience of representing the protected party before concurrent proceedings before the First-Tier Tribunal and the Court of Protection and Nearest Relative Displacement Proceedings.

Francesca has extensive experience in cases concerning the interface between the Mental Health Act and the Mental Capacity Act.

### **Children and Mental Health, Mental Capacity and Deprivation of Liberty**

Francesca has extensive experience involving the complex area of children and mental health and mental capacity law. Francesca has experience of representing children, public bodies and family members in cases involving children detained under the Mental Health Act, cases under the Inherent Jurisdiction of the High Court seeking the court's authorisation for the deprivation of a child's liberty and claims under the Human Rights Act 1998 for unlawful deprivation of a child's liberty and breaches of Article 8 of the ECHR as a result of the failings of public authorities in care proceedings.

Francesca regularly provides advice to local authorities and children's Guardians in relation to the complex area of consent and deprivation of liberty in children's cases.
