

- Section 47B(1) of the Competition Act 1998.
- Requirement for a Collective Proceedings Order from the **Competition Appeal** Tribunal.
- Mastercard Inc v Merricks [2020] UKSC 51









# Informally constituted group actions/test cases

- Abbott & Others v Ministry of Defence [2022] EWHC 1807
- Consolidation/order that cases be managed and tried together.
- Test cases: see OFT v Abbey National Plc [2009] UKSC 6









### Litigation funding

- What's it for? ATE insurance/disbursements/ele ments of discounted CFAs.
- How much its costs: 30% of the recovery or 3x the value of the funding
- Maintenance/champerty/cont rol.
- Paccar Inc and Others v Road **Haulage Association Limited** and Others [2021] EWCA Civ 299.









#### Retainers

- Conditional fee agreements (CFAs).
- Damages based agreements (DBAs).
- Crowdfunding? Securitisation of funding?
- Costs of funding not recoverable.









#### ATE insurance

- Important: what if you lose?
- Underpin disbursements.
- Amount.
- Absence can be reason for refusing GLO.
- RBS Rights Issue Litigation [2017] EWHC 463 (Ch)









# Costs budgeting and capping

- Part 3 CPR and Practice Directions 3D and 3E.
- Sharp v Blank [2015] EWHC 2685 and [2017] EWHC 141 (Ch)
- McAlpine [2015] EWHC 3543









### Security for costs

- See rule 25.13 CPR: particularly useful where the claimants are corporate bodies. Eg financial misselling or expatriates.
- ATE insurance: see Premier Motorauctions v **PricewaterhouseCoopers** LLP [2017] EWCA Civ 1872









#### Costs orders

- Can be very complex.
- Departing from the "general rule".
- Costs of particular issues.
- GLO costs.
- Non Party Costs Orders.









### Costs considerations on detailed assessment

- Usual to be taken in stages.
- Motto and others v Trafigura Ltd [2011] EWCA Civ 1150
- Preliminary issues including points of principle.
- Deutsche Bank AG v Sebastian Holdings Inc [2023] EWHC 9 (SCCO)
- Not a group case, but useful for expert fees and time recording.
